**Proof-of-Trust - Digital trust using the example of crypto custody**  
Whitepaper of the Digital Trust expert group

The events surrounding the crypto trading platform "FTX.com" show the need to provide trustworthy proof of the security of customer assets held in trust. If crypto trading venues or the crypto custodians involved do not currently have a "proof of reserves" (PoR), such procedures can be useful in terms of fostering trust.

PoR is a cryptographic verification procedure to prove the existence, completeness and integrity of crypto assets. The aim is to increase trust in the intermediary's ability to pay out from the customer's perspective.

This article by the Digital Trust expert group outlines the concept of PoR and also shows possible solutions with regard to the limits of the informative value of PoR as a measure to increase trust. The interaction of PoR and ISACA Digital Trust is referred to here as Proof-of-Trust.
