JOB PRACTICE UPDATE CISA

The Certified Information Systems Auditor® (CISA®) certification is undergoing a job practice update in 2024.

The **updated exam preparation materials** will be **available in May 2024**.

If you wish to take the **exam with the current content**, you will only be able to do so **until the end of July 2024**. The CISA exam will be conducted with the new exam content from August 1, 2024.

We have also taken these changes into account in our course planning. Our CISA exam preparation courses in the first half of the year will still take place with the current materials (basis: CISA Review Manual 27th Edition), all later courses (beginning with course no. CISA_2023_4VK) with the new ones (basis: CISA Review Manual 28th Edition).
